LETTER FROM THE MANAGER

DEAR TRANSIT FRIENDS,

I reported at the end of last year in our fourth quarter eNewsletter that we were waiting on the review of proposals for the new RTAP contract to be completed. I am happy to share that we were selected by MoDOT to manage the operations of Missouri RTAP under a three-year contract. We will continue providing the same great RTAP services you have come to know and trust. Writing the proposal gave us an opportunity to outline our plans for the next few years and reflect on our successes over the past five years. Partnerships were key in the development of an effective and efficient RTAP program. We want to continue strengthening our relationships with the transit agencies we serve. I have traveled throughout the state alongside MoDOT personnel meeting with transit agencies in past years to assess your needs and satisfaction with the program. This proved very valuable in highlighting some additional training needs. I would like to hold similar meetings this year to identify topics of interest beyond those that we currently offer. If the agencies in your area are planning to meet in the coming months, I would be eager to attend and provide an update on the Missouri RTAP program. This would also allow me to answer any questions you may have on our plans.

I do want to let everyone know about a change to the mileage rate. If you drive a personally owned vehicle (POV) versus a transit vehicle to any conference or workshop that is eligible for scholarship reimbursement, please note as of February 1, 2018, the mileage reimbursement rate has been reduced from 50.5 cents per mile to 37 cents per mile for travel by personal vehicle. This revised policy aligns with the current mileage rate for the state of Missouri. We realize this is a significant reduction; however, we unfortunately had no control over the change. Please contact us if you have any questions or concerns.

Please plan any anticipated travel well in advance. Remember that we require flying versus driving comparisons with rates secured at least 30 days in advance. The conference season will be upon us before we know it. Please submit travel requests as early as possible. Remember that we always want to hear from you. ATTENTION!

MO Transportation Task Force Report Calls for \$50-70 Million in Funding for Transit and other Multi-modal Transportation

IN 2017, THE GENERAL ASSEMBLY ADOPTED HCR 47, which established the 21st Century Missouri Transportation System Task Force – a 23-member, bipartisan panel comprised of participants from the House of Representatives, Senate and Executive Branch, as well as the private sector. The Task Force was directed to evaluate Missouri’s transportation system and make funding recommendations.


Between June and December of last year, the task force met throughout the state on 10 separate occasions. These meetings provided the opportunity for the public to weigh-in and resulted in more than 100 individuals testifying on a variety of transportation issues.

The Task Force released its recommendation report on January 2, 2018, calling for an increase in state gas tax revenues to deliver economic growth, and the creation of a dedicated revenue stream of \$50 to \$70 million for transit and other multi-modal transportation. More specifically, the Task Force is recommending a 10 cent hike in the gas tax and 12 cent hike in the diesel fuel tax. This would bring gas and diesel fuel to 27 cents and 29 cents per gallon, respectively, when both have been set at 17 cents per gallon for nearly two decades. According to State Rep. Kevin Corlew, a fuel tax hike would provide an additional \$430 million a year for roads and bridges. The proposed fuel tax hike would have to be passed by both the legislature and Missouri voters.


With regards to the \$50 to \$70 million for the dedicated stream of funding for transit and other multi-modal transportation, the report notes that it is not suggesting any additional taxation of Missouri citizens. Rather, it proposes a revision of Missouri’s “Timely Filing Discount” that currently allows retailers to retain two percent of the sales and use taxes they collect from customers if they remit those taxes to the state in a timely manner. This vendor discount is uncapped, remains the second-most generous in the country and cost Missourians about \$115 million in 2016. A discount at a lesser percent, or implementation of a cap, would provide revenue savings, which could then be directed to multi-modal transportation. The Task Force also recommends that any potential savings be statutorily designated to go into the non-highway transportation fund.

According to the American Public Transit Association, every \$1 dollar invested in public transportation systems yields a \$4 return. Given the fact that transit funding in Missouri has been slashed to \$1.7 million for FY2018, Citizens for Modern Transit, the transit advocacy organization in St. Louis, is encouraged by the recommendation. The organization understands that while the plan may come with challenges, it is on the right track as it relates to transit funding.

“While any transportation plan will face significant challenges in this legislative session, I am pleased to see that the Task Force took into account the need to recommend specific investment in transit and multi-modal transportation. MPTA members stressed the importance of this investment in their testimonies at many of the public meetings that were held in 2017. This is most definitely a good first step for transit,” said Dorothy Yeager, President of MPTA.



PART 40 FINAL RULE - DOT SUMMARY OF CHANGES

US DEPARTMENT OF TRANSPORTATION

NOVEMBER 13, 2017, THE DEPARTMENT OF TRANSPORTATION (DOT) published a final rule in the Federal Register (82 FR 52229). The rule, among other items, added four semi-synthetic opioids (i.e., hydrocodone, oxycodone, hydromorphone, oxymorphone). It also added methylenedioxyamphetamine (MDA) as an initial test analyte and removed the testing for methylenedioxyethylamphetaime (MDEA).

When is the final rule effective?

- The final rule is effective January 1, 2018.

What does this mean for employees?

- You will also be tested for four semi-synthetic opioids (i.e., hydrocodone, oxycodone, hydromorphone, oxymorphone). Some common names for these semi-synthetic opioids include OxyContin®, Percodan®, Percocet®, Vicodin®, Lortab®, Norco®, Dilaudid®, Exalgo®. In addition, you will no longer be tested for MDEA.

What does this mean for employers and Consortium/Third Party Administrators (C/TPA)?

- As an employer or C/TPA, you will no longer be required to submit blind specimens to laboratories.

What does this mean for urine collectors?

- The shy bladder process has been modified so that the collector will discard any specimen provided during the collection event when the employee does not provide a sufficient specimen by the end of the three hour wait period.

What does this mean for laboratories?

As an HHS-certified laboratory you will:

- Add four semi-synthetic opioids: hydrocodone, oxycodone, hydromorphone; oxymorphone to your DOT testing panel;
- Add MDA as an initial test analyte;
- Remove testing for MDEA;
- Add three more fatal flaws to the list of reasons when a laboratory would report a 'rejected for testing' specimen; and
- Need to modify the reports [in Appendix B & C] you provide to employers and the DOT.

What does this mean for Medical Review Officers (MRO)?

- Several of your MRO drug test review processes have been modified. For example:
- The term 'prescription' has been clarified;
- You have authority to conduct D,L stereoisomer and THC-V testing; and
- The timing when you communicate a significant safety risk has been modified.

What does this mean for alcohol technicians?

- The list of NHTSA-approved Alcohol Screening Devices and Evidential Breath Testing Devices will appear on ODAPC's website.

What does this mean for service agents?

- Collectors, alcohol testing technicians, MROs, and Substance Abuse Professionals will be required to subscribe to ODAPC's list-serve at: https://www.transportation.gov/odapc/ListServe_Notices.
- Unauthorized use of DOT-branded items (such as logos or emblems) on a service agent's website, publications, etc., could be a basis for the DOT to initiate a Public Interest Exclusion proceeding.

What are some of the other changes to Part 40?

- The DOT added a new section reiterating that, in the DOT testing program, only urine specimens can be collected and analyzed at HHS-certified laboratories.
- The DOT added language further emphasizing the existing DOT prohibition on the use of DNA testing on DOT drug-testing specimens.
- The final rule made minor modifications to certain section headings.
- The final rule moved the list of Substance Abuse Professional certification organizations from the rule text to ODAPC's website.
- The final rule moved the MIS instructions from Appendix H to ODAPC's website.

- Outdated compliance dates were removed and links were updated.
- Appendices B, C, D, and H were updated.
